- i. signed by two or more Shareholders from the same Region (i.e., Region Three) as the candidate (other than the candidate or, where the candidate represents a corporate Shareholder, the corporate Shareholder);
- ii. accompanied by a notice in writing under the candidate's hand consenting to his or her candidature for office; and
- iii. accompanied by a completed candidate profile document (as described in the Nomination Form).

The nominations must be received by ADFC no later than **5:00pm (AEDT)**, **Friday 7 October 2022** and can be delivered by:
